## *Requirements for Caregivers*

Our requirements for caregivers are very high, but then so are our wages. Basically, we are hunting caregivers that have:

- \* 3 to 5 years professional private-duty caregiving experience
- \* A minimum of some college coursework
- \* Level I criminal background check, screening and police/arrest record check
- \* Universal Precautions and CPR Certification
- \* Totally clean driving record
- \* Their own transportation and auto insurance

## *Also Helpful*

We especially look for CNA caregivers with assisted living or hospice experience. Additional certifications in Alzheimer's and Dementia are helpful.

## *Computer Use*

Much of our scheduling and daily log notes are done via computer. You must have daily access to email and be able to receive, download and print attachments.

## *Pay Scale*

Starting pay is \$9.00 with advancement to \$9.50 after 6 months. Long shifts of 12 hours for clients requiring 24/7 care, pay a per diem rate of \$95.00 per shift.

Time-and-one half is paid for holidays, which are Easter, Independence Day, Thanksgiving, Christmas Eve and Christmas Day, New Year's Eve after 6 pm and New Years Day.
